	Please confirm that next proposal can be acceptable within technical requirements: Propeller: The dredger must have two propeller, which can be hydraulically turned sideways for steering and lifted up from the water when walking from water to ground, equipped with anti-weed device to avoid coiling of weed on the propeller	The dredger must have 1 or 2 propeller(s) which can be hydraulically turned sideways for steering and lifted up from the water when walking from water to ground, equipped with anti-weed device to avoid coiling of weed on the propeller. Propellers have to be designed in such a way that no weed can get caught in the auger.
2.	Please confirm that next proposal can be acceptable within technical requirements: Front spuds should be able to swivel front- and backwards to support the creeping mode.	Proposed technical requirement is not obligatory.

Potential supplier must provide technical and financial information for 4 sets of required equipment (Multipurpose dredger, Additional works tools, Pipeline components and Accessories).
		Financial data for 4 sets of equipment must be provided in document ANNEX IV: Budget breakdown (Model financial offer) on unit price basis.
		Potential suppliers must provide training service according to the request. Financial data for training services on lump sum basis can be provided by supplier, but it is not obligatory if training price will be included within 4 sets of equipment prices or if supplier will provide training services free of charge.
		All other services such as installation, additional insurance or other which are not covered or included in prices of 4 sets of equipment and/or training services should be quoted on Lump sum basis.
