1.	In VOLUME 1/SECTION 4/FORM 4.6.4. item 4.6.4.1 is defined as follows: List of contracts of similar nature and scale performed during the past 5 years. In Contract notice and Instruction to tenderers is defined that references must be performed during the last 3 years from the submission date. Please explain which period should be used for references.	In documents Contract notice (d2_contractnotice_en) and Instruction to tenderers (d4b_itt_en) is defined that tenderer must have Technical and professional capacity as follows: • it must have completed at least 1 project of amount of at least 2.000.000,00 EUR related to construction and/or reconstruction and/or rehabilitation works of hydrotechnical facilities (civil and/or mechanical works), which were implemented during the following period: 3 years from the submission deadline. In document d4e_techofferquestion_en (VOLUME 1. SECTION 4) FORM 4.6.4 - EXPERIENCE AS CONTRACTOR) must be stated as follows: 4.6.4.1 List of contracts of similar nature and scale performed during the past 3 years.
2.	Article 50, item 50.1 of the SPECIAL CONDITIONS prescribes that periodical payments for statements are issued on monthly basis. Could you please clarify the meaning of the mentioned numbers of months 3, 7, 11, 15, 19, 22 and 24? Does this mean that for 3 issued monthly statements which will be executed within 1. Periodical payment in the percentage of 5,75% within 90 days as stated in Article 44. item 44.3 b) of the GENERAL CONDITIONS. Does it mean that in the third month from start of the contract and works payment will be executed practically for 3 accumulated monthly statements?	Document General Conditions (d4p_annexgc_en) VOLUME 2 as part of tender dossier should be used for information to tenderers related to general conditions which can be applied according to PRaG procedures. According to Special Conditions (article 50, item 50.1) is defined that works which will be execute within this contract will be pay in 6 interim payments and the Final payment. Interim payments will be realized according to Article 50, item 50.1 of the Special conditions. Contractor is obligated to issue one (1) invoice for realized works within each Interim period and one (1) invoice for realized works within Final implementation period.

In VOLUME 1/ SECTION1: INSTRUCTION TO TENDERERS, point 12.2.1. is defined as follows: The selection criteria for each tenderer are as follows: The tenderer has presently employed welders on full time basis as follows: - minimum four (6) attested welders with diploma of REL weld plate - minimum four (4) attested welders with diploma of REL welding of angular connections Does Contracting Authority require 4 or 6 certified welders with a REL welded plate?
