

Minutes of the meeting

Subject: Construction of inspection path L=1500 m on the right bank of Jegrička

Ref. no: HUSRB/1602/11/0010-TD-03

Meeting point/Location: Jegrička Center, Temerinski put BB Road

Site visit location: Jegrička canal from km 38+500 to km 40+000 in Sirig

Date: 16/05/2019

Briefing: 10:00 AM local time

Mina Jakovljević Zavarko, engineer and Jasminka Gajer, project administrator held a meeting with potential bidders who expressed interest to participate in tender for works on Construction of inspection path L=1500 m on the right bank of Jegrička Stream.

The participants have been briefed on the location of future works on riverside path construction and description of works by being provided insight into Study on "Riverside path construction on the Jegrička riverbank in Sirig".

Site visit:

Site visit started around 10:15 from section 38+500 (Sirig Bridge) along the right riverbank upstream to section 38+900 km which was the most suitable location to gain insight into the situation of site location which will be included in subject works. Taking into consideration that some sections of the site location were inaccessible due to daily rainfall, the attendees agreed not to visit the entire section which is in terms of terrain configuration and execution of works exactly the same as the section that they have previously visited. Precise layout of the future path will be determined with the Contractor prior to commencement of works on path construction.

Technology of execution of works has been presented and all items from relevant Bill of Quantities have been observed. Site visit was finished at 11:00 h local time.

All attendees were briefed on works being performed within the Jegrička Nature Park territory, at section which is under 3rd degree protection i.e. that execution of works must be performed in accordance with environmental conditions issued by the Institute for Nature Conservation of Vojvodina Province.

Potential bidders have been given the **(Certificate of attendance on clarification meeting and site visit)**, which will form a constituent part of tender documentation. They have also been

informed that they can ask any further questions via email enclosed in tender documentation, respecting the deadline stipulated in the Instruction to tenderers.


